Good Morning, my name is Michael Donahue and I am the Luzerne-Wyoming Counties Drug and Alcohol Program Administrator. I would like to take this opportunity to thank State Representative Aaron Kaufer for conducting this Hearing to review the devastation caused by heroin/opioid usage, and the critical social issues caused by this epidemic.

- The opioid epidemic in Luzerne and Wyoming Counties, as is the case throughout the Commonwealth of Pennsylvania continues to take a toll on our Communities health and economic stability.
- The Luzerne-Wyoming Counties Drug and Alcohol Program continues to see heroin/opioid usage as the primary substance of abuse requiring treatment within our Single County Authority (SCA).
- As the Drug and Alcohol Administration for Luzerne and Wyoming Counties, the SCA has expanded the medicated assisted treatment available and has continued to refer to inpatient treatment those individuals suffering from heroin/opiates use disorders for all of our residents. Specifically, there are two methadone programs with a capacity of over 700 slots available to individuals from the Northeastern Region in Pennsylvania.
- Over the past 10 years heroin and other opiates are the number one or number two substance of abuse for Luzerne and Wyoming Counties. The total number of overdose deaths in Luzerne County for Calendar Year 2014 was 67, and the total number of overdose deaths in Wyoming County for Calendar Year 2014 was 17. It is estimated that 67% of the afore-mentioned deaths had heroin and other opioids identified as the cause. The total number of overdose deaths in Luzerne County for Calendar Year 2015 was 95 and we are still trying to secure Wyoming County's 2015 numbers.
- Bed availability and capacity issues are concerns which must be dealt with on a daily basis when attempting to coordinate care for individuals seeking help.
- The Luzerne-Wyoming Counties Drug and Alcohol Case Management Unit provides assessments and case coordination for Luzerne County Residents through appointments scheduled at our site in Luzerne County. These services are also available in Wyoming County at sites in that county.
- It is estimated that 70% of all drug treatment court and criminal justice referrals have a substance use disorder with the primary drug of abuse being heroin/opioid.

- As a response to the heroin/opioid epidemic, the Luzerne-Wyoming Counties SCA is working with first responders throughout the two county region. This will assure that Naloxone is available for administration onsite for those individuals who are found to be unresponsive due to opioid usage. The SCA has also been involved with the District Attorneys in Luzerne and Wyoming Counties to discuss establishing a Regional First Responders Initiative of Law Enforcement to improve the potential for further reversals of overdosed individuals. To date, there have been over 100 reversals reported, with 5 individuals being from Wyoming County.
- The SCA has also encouraged the Prevention Providers in both Luzerne and Wyoming Counties to incorporate the harms and effects associated with heroin and opiate usage into all of their middle school and high school prevention programming.
- The Luzerne-Wyoming Counties Drug and Alcohol Program is also working closely with the District Attorneys from Wyoming County to identify gaps in services needed to help those individuals who are involved with heroin/opioid use disorders. The SCA was involved with a mapping of Mental Health and Drug and Alcohol Services available to Wyoming County residents.
- The Luzerne-Wyoming Counties Drug and Alcohol Program is also very much involved with the Probation Offices of both counties to assure that screening and assessments are completed in a timely fashion with coordination of client continuum of care as the primary goal.
- Further development of Recovery Oriented Systems of Care (ROSC) is occurring in both Luzerne and Wyoming Counties. The main objective of this initiative is to establish recovery centers where individuals can go and be with others who are attempting to maintain a drug free lifestyle. Also, the second objective is to train and hire Certified Recovery Specialists (CRS) to meet with those individuals returning to their home environments thus giving additional support to their recovery efforts. On May 27<sup>th</sup>, 2016 there were 27 individuals who successfully completed the CRS trainings, and will sit for their certification examination in June 2016.
