## FOREWORD

PLEASE CONSIDER THIS DOCUMENT AS A GRASS ROOTS EFFORT TO FOSTER ALL MEANINGFUL EFFORTS TO REFORM THE PENNSYLVANIA WELFARE SYSTEM. THIS DOCUMENT HAS BEEN DRAFTED BY A SMALL BUSINESS, WHICH HAS EXISTED FOR THE LAST TWENTY-FIVE (25) YEARS IN THE FACE OF STIFF COMPETITION IN RURAL SW PENNSYLVANIA. THIS DOCUMENT HAS BEEN DRAFTED BY A BUSINESSMAN WITH TWO COLLEGE DEGREES AND THIRTY-FIVE YEARS IN THE RETAIL FOOD BUSINESS.

THE CITIZENS MAKING THIS PRESENTATION, GIVING TESTIMONY AND OFFERING SUGGESTIONS TO REFORM THE PA WELFARE SYSTEM WITNESS, IN THEIR DAILY BUSINESS FUNCTIONS, WHAT REALLY HAPPENS WITHIN THE WELFARE SYSTEM. THESE PEOPLE ARE HARD WORKING, TAX PAYING CITIZENS WHO FEEL THAT THE PA WELFARE SYSTEM IS NOT FUNCTIONING PROPERLY AND ABUSE HAS REACHED AN ALARMING STATE.

THE BUSINESS AND THE STAFF WHO TESTIFY, DO SO NOT FOR PERSONAL GAIN, BUT RATHER, THEIR COMMON FEAR THAT THE COMMONWEALTH CAN NO LONGER AFFORD SUCH AN "ENTITLEMENT PROGRAM" AND ENCOURAGES THOSE WITHIN THE WELFARE SYSTEM TO REMAIN IN THE WELFARE SYSTEM OVER POSSIBLY A MULTI-GENERATIONAL TIME FRAME.

THOSE GIVING TESTIMONY ARE AWARE, THAT BY INFORMING THE LEGISLATIVE BODY OF WHAT REALLY HAPPENS IN THE RETAIL ENVIRONMENT, THEY ARE POSSIBLY EXPOSING THEIR BUSINESS AND THEIR VERY LIVELYHOOD TO ATTACKS FROM THOSE WHO SUPPORT SUCH A FLAWED SYSTEM. THESE PEOPLE SEEK NOTHING IN RETURN, OTHER THAN TO CORRECT THE SYTEM THAT HAS BEEN SUCH A DRAIN ON THE COMMONWEALTH'S TAX REVENUE BASE. THIS DRAIN RESULTS IN ADDITIONAL, UNNECESSARY TAXATION TO BUSINESSES AND INDIVIDUALS, THUS PENNSYLVANIA BECOMES AN UNATTRACTIVE PLACE TO LOCATE A BUSINESS OR PERMANENT RESIDENCE. UNFORTUNATELY, THIS LEADS OTHERS TO REGARD PENNSYLVANIA AS AN "UNATTRRACTIVE STATE", AS WITNESSED BY ITS RANKING AMONG OTHER STATES.

WE ASK ALL LEGISLATORS AND GOVERNING AGENCIES TO SERIOUSLY CONSIDER THIS DOCUMENT. WE REQUEST THAT THIS INFORMATION BE PERMITTED TO SERVE AS A TRUE FOUNDATION FOR WELFARE REFORM, THAT LIMITS THE AMOUNT OF WELFARE THAT ONE CAN OBTAIN AND CAREFULLY DOCUMENTS RESIDENCY, COMPLIANCE AND BECOMES A "SAFETY NET" AND NOT A LIFELONG COUCH OF COMPLACENCY.

FINALLY, BY REFORMING THE COMMONWEALTH'S WELFARE SYSTEM, WE CAN THEN MOVE FORWARD TO ADDRESS AND CORRECT THE FEDERAL FOOD STAMP PROGRAM WHICH IS ALSO SEVERLY FLAWED FROM A NUTRITIONAL AND ETHICAL POINT OF VIEW.

SUGGESTED PENNSYLVANIA WELFARE REFORM

JUNE 2010

1. ELIGIBILITY:

ANY PERSON APPLYING FOR WELFARE MUST HAVE BEEN A RESIDENT WITHIN THE COMMONWEALTH FOR A MINIMUM OF 18 CONTINUOUS PRECEEDING MONTHS AND FILED A PA DEPT OF REVENUE INCOME TAX FORM FOR THE PREVIOUS TAX YEAR.

VERIFICATION WOULD ALSO INCLUDE:

- \* VOTER REGISTRATION CARD
- \* PHYSICAL RESIDENCE ADDRESS, NO P.O. BOX
- \* AT LEAST ONE UTILITY BILL VERIFICATION
- \* GOVERNMENT PHOTO I.D./FINGERPRINT REQ'D

2. WHO IS ELIGIBLE TO RECEIVE WELFARE SUPPORT?

ALL PENNA. RESIDENTS ARE ELIGIBLE, AS STATED ABOVE, TO RECEIVE WELFARE OVER THEIR LIFETIME, AS NEEDED, WITH LIMITS STATED BELOW, IN CONJUNCTION WITH THE CONCEPT OF LIMITING LIFE-LONG ABUSE AND PRUDENT PARTICIPATION IN THE WELFARE SYSTEM.

A. ALL CALCULATIONS FOR MAXIMUM BENEFIT PERIOD WILL BE BASED ON INSURANCE INDUSTRY ACTUARIAL

STATISTICS THAT VERIFY THE EXPECTED LIFE EXPECTANCY, ACCORDING TO A PERSON'S BIRTH DATE AND SEX. THESE ARE UNBIASED NATIONAL STUDIES. THESE STUDIES EXPRESS THE DATA IN WHOLE AND DECIMAL FRACTIONS OF YEARS. AN HYPOTHETICAL EXAMPLE WOULD BE FOR A MALE BORN ON 3/1/1955 = 73.7 YEARS, WHILE A FEMALE BORN ON 3/1/1955 = 79.9 YEARS.

B. IN ORDER TO "GRANDFATHER" THIS PROPOSED LEGISLATIVE CHANGE, IT WOULD APPLY ALL PERSONS BORN AFTER JAN. 1, 1955.

3. PROPOSED MAXIMUM WELFARE BENEFIT YEARS

A. EACH ELIGIBLE PERSON WOULD BE ELIGIBLE FOR A MAXIMUM OF TEN(10) PERCENT OF THEIR LIFE EXPECTANCY AS OF THE DATE OF THEIR BIRTH, IN WHOLE AND DECIMAL FRACTIONS OF LIFE SPAN EXPECTANCY, TO ACCESS THE STATE'S WELFARE SYSTEM. CONTINUING THE EXAMPLE, FOR THE MALE AND FEMALE STATED ABOVE, IT WOULD IMPLY:

MALE, BORN 3/1/1955 ---- 7.37 YEARS OF WELFARE

FEMALE, BORN 3/1/1955 --- 7.99 YEARS OF WELFARE ONCE THESE YEARS WERE EXHAUSTED BY THE CLAIMANT, THE CLAIMANT WOULD NOT BE ELIGIBLE FOR WELFARE BENEFITS FOR THE REMAINDER OF HIS/HER LIFETIME.

4. FOR THOSE, WHO NEVER USE OR ONLY PARITALLY USE THE AVAILABLE BENEFIT LIMIT IN THEIR LIFETIME, UPON REACHING THEIR DESIGNATED SOCIAL SECURITY FULL RETIREMENT AGE, THESE INDIVIDUALS WOULD RECEIVE THE BALANCE OF THEIR REMAINING UNUSED 10% AMOUNT, HELD IN A SEPARATE, NON-ACCESIBLE TO THE PA. STATE GENERAL REVENUE FUND, ACCOUNT AND THEN PAID OUT TO THE RETIREE, OVER A SIX(6) YEAR PERIOD IN EQUAL MONTHLY AMOUNTS, WITH INTEREST. THE UNUSED 10% AMOUNT WOULD ACCRUE INTEREST DUE, BASED ON THE CURRENT U.S. TREASURY BILL 12 MONTH RATE, BEGINNING AT AGE 55 THROUGH THE INDIVIDUAL'S SOCIAL SECURITY FULL RETIREMENT ELIGIBILITY MONTH THAT THEY CHOOSE TO RETIRE. THIS ACCRUED INTEREST WOULD BE PAYABLE BEGINNING IN THE FIRST MONTHLY PAYMENT. ONE(1) PER-

CENT OF THE ACCRUED INTEREST WOULD BE DEDUCTED ON AN ANNUAL BASIS, AND BE A SOURCE OF FUNDS TO VERIFY, ADMINISTER, MONITOR AND ENFORCE COMPLIANCE OF THE CLAIMANTS PARTICIPATING IN PENNA. WELFARE SYSTEM. PARTICIPANTS COULD BE TRACKED VIA THE STATE FILING OF AN INCOME TAX FILING, VALID SOCIAL SECURITY NUMBER AND FINALLY BY FINGERPRINTS AND/OR OPTICAL VERIFICATION SYSTEMS THAT ARE PRESENTLY AVAILABLE.

5. CURRENT, VERIFIED CASH WELFARE ABUSES AT RETAIL:

- A. USE CASH PORTION TO PURCHASE TOBACCO PRODUCTS
  - SOME BUY 3 - 4 CARTONS OF CIGARETTES DURING ONE PURCHASE TRANSACTION.
- B. PURCHASE FOOD AT CASH REGISTER WITH EBT CARD, THEN PROCEED TO LOTTERY AND PURCHASE \$30.00, \$40.00 OR \$50.00 OF INSTANT LOTTERY TICKETS WITH CASH ACCESSED THROUGH RETAILER'S ATM TO FUND THE LOTTERY PURCHASE.
- C. WOMAN COMES INTO THE STORE, WHO OWNS A PERSONAL CARE HOME, AND HAS A \$1,400.00 BALANCE ON HER ACCOUNT. HOW DOES THIS HAPPEN????
- D. CUSTOMERS COME INTO THE STORE AND STATE THAT THEY USE THEIR EBT CARD FOR BINGO GAME FUNDING.
- E. FORMER CASHIER COMES INTO THE STORE WITH HER SIX(6) SOMEWHAT UNRULLY CHILDREN, AND HAS OVER

\$900.00 ON THE ACCOUNT BALANCE, THEN LEAVES THE STORE AFTER MAKING THE LARGE ORDER PURCHASE & GETS INTO A BRAND NEW VAN, SUPPOSEDLY IN HER FATHER'S NAME. NO HUSBAND, JUST MOVES FROM BOYFRIEND TO BOYFRIEND, AND BOTH OF THEM ARE ELIGIBLE AND RECEIVE WELFARE SUPPORT PAYMENTS.

F. MOTHER AND DAUGHTER COME IN SHOPPING TOGETHER, EACH HAVING THEIR OWN SHOPPING CART, PROCEED THROUGH TWO DIFFERENT REGISTER CHECKOUT LANES. THE DAUGHTER, WHO IS ON WELFARE, SWIPES HER EBT CARD FOR HER ORDER, THEN QUICKLY PROCEEDS TO HER MOTHER'S LANE AND SWIPES HER EBT CARD AGAIN, TO PURCHASE HER MOTHER'S GROCERY ORDER. BY USING THIS METHOD, THE DAUGHTER MAINTAINS THAT "SHE IS USING HER FULL WELFARE MONTHLY ALLOTMENT" YET THE MOTHER IS IN ESSENCE RECEIVING WELFARE SUPPORT WITHOUT QUALIFYING. THERE NEEDS TO BE SOME TYPE OF "TIME DELAY" IN THE CARD SWIPE PROCESS THAT WHEN IT ACTUALLY COMPLETES THE TRANSACTION. POSSIBLY, A FIVE (5) HOUR WAIT BEFORE THE EBT CARD COULD ALLOW ANOTHER FOOD ORDER PROCESSING TRANSACTION. WE ARE IN FULL SUPPORT OF A "NO CASH AVAILABLE" WELFARE EBT CARD. IT HAS TO BE USED IN THE "SPIRIT OF PROVIDING ESSENTIAL NEEDS". EXAMPLES OF ESSENTIAL NEEDS ARE: IVORY BAR SOAP, JOHNSON & JOHNSON BABY SHAMPOO, BAN ROOL-ON DEODORANT, LIQUID LAUNDRY SOAP, CHLORINE BLEACH, AMMONIA, LIQUID DISH DETERGENT, BATH TISSUE, FACIAL TISSUE.

G. IN THE COMPETITIVE BUSINESS WORLD, THE STORE HAS THE OPTION TO PERMIT "CASH BACK" AT THE END OF AN EBT TRANSACTION. IN OUR CASE, WE CHOSE THE OPTION OF NO CASH BACK, AS WE ARE NOT A BANK. THIS IS MORE OF A PRINCIPLE, RATHER THAN A MARKETING RULE, BUT THEN MONETARY FUNDS TO DO THIS TYPE OF "CASH OUTFLOW" COULD POSSIBLY RAISE CRIME INSURANCE RATES FOR OUR OPERATION. WAL-

MART, ON THE OTHER HAND, PERMITS ITS CASH REGISTER SYSTEM TO GIVE \$50.00 CASH BACK. WE FEEL THAT THIS IS A WAL-MART ENTICEMENT TO THE WELFARE RECEIPTANT TO SPEND MORE CASH IN WAL-MART. WE WILL HAVE TO LOOK AT THIS, GIVEN THE HIGH PERCENTAGE OF EBT CUSTOMERS RESIDING IN THE AREA. YET, WE ARE NOT FOND OF DOING THIS TYPE OF "CASH BACK PROCESS".

- H. CUSTOMER COMES IN AND HAS THREE (3) EBT CARDS: HIS OWN EBT CARD, HIS DAUGHTER'S EBT CARD AND HIS GIRLFRIEND'S EBT CARD. HOW DOES THIS TYPE OF ABUSE GET MONITORED AND CORRECTED??? WE ARE THE MERCHANT, NOT THE ENFORCEMENT ARM OF THE COMMONWEALTH'S WELFARE SYSTEM.
- I. USUALLY, EBT FUNDS ARE AVAILABLE ON SELECTED DATES AT APPROXIMATELY 12:01 AM. BY 12:30AM, THE CLAIMANTS ARE IN THE STORE SHOPPING FOR THEIR "PREFERRED ITEMS".

THE FOLLOWING SUGGESTIONS ARE BEYOND THE SCOPE OF THIS DISCOVERY HEARING, AS IT INVOLVES THE FEDERAL FOOD STAMP PROGRAM. HOWEVER, IT IS MEANINGFUL AS THERE IS A "LINK" TO ADDITIONAL WASTE, PROMOTION OF IMPROPER NUTRITION AND "UNDER THE RADAR" ABUSE OF THE FEDERAL FOOD STAMP PROGRAM. WE FEEL THAT THE "WIC" (WOMEN, INFANTS AND CHILDREN) AGENCY, WHICH HAS DONE A VERY ADMIRABLE JOB OF FOSTERING PROPER NUTRITION WITH MOTHERS AND SMALL CHILDREN, SHOULD BE GIVEN THE AUTHORITY TO MONITOR AND APPROVE THE FOODS THAT ARE FOOD STAMP ELIGIBLE. BY ALLOWING THIS AGENCY TO MONITOR ALL GOVERNMENT APPROVED FOOD PROGRAMS, CONSISTENCY IS BROUGHT FORWARD TO PREVENT ABUSE AND COMBAT THE OBESITY PROBLEM THAT IS SO PREVELANT IN AMERICA TODAY, ON A NATIONAL LEVEL.

IT IS OUR HOPE THAT WHEN THE NEW 12<sup>TH</sup> DISTRICT U.S. CONGRESSIONAL REPRESENTATIVE IS ELECTED THIS COMING SPRING; THAT WE CONVENE AGAIN, AND BRING THIS PERSON INTO THE DISCUSSION GROUP TO BEGIN A CAMPAIGN TO CORRECT THE ABUSES IN THE U.S. FEDERAL FOOD STAMP PROGRAM WHICH ALSO UTILIZES THE SAME EBT ELECTONIC CARD.

SOME GENERAL COMMENTS OF COMBINATION FOOD STAMP/WELFARE THAT WE SEE AT RETAIL LEVEL ARE:

1. THESE PEOPLE DO NOT BUY HEALTHY FOODS. THERE IS EXCESSIVE PURCHASES OF SODA POP, SNACKS, CANDIES, COOKIES, ETC.
2. BIGGEST VOLUME PURCHASES ARE IN SODA POP, PREPARED FROZEN ENTREES, PARTY ITEMS, FROZEN PIZZA, PREPARED COLD SANDWICHES.
3. WE'VE SEEN FOOD STAMP/WELFARE CUSTOMERS BUY NOTHING BUT A FULL CART OF SODA POP. AT THE CASH REGISTER, WHEN THE FOOD STAMP FUNDS ARE EXHAUSTED, THESE CUSTOMERS USE THE EBT CASH BALANCE TO COMPLETE THE PURCHASE. POSSIBLY, THIS TYPE OF CUSTOMER IS SELLING THEIR SODA POP PURCHASE TO A SMALL STORE, VARIOUS CLUBS, FLEA MARKETS, ETC. FOR CASH OR TRADE. THEN THE CASH IS USED/TRADED FOR CIGARETTES, ALCOHOL OR ILLEGAL DRUGS. THERE COULD ALSO BE BARTERING GOING ON FOR THE SODA POP TO OBTAIN OTHER ITEMS.
4. BUY PREMIUM CUTS OF MEAT, FRESH SEAFOOD (SHRIMP) INSTEAD OF SEARCHING OUT QUALITY/VALUE ITEMS TO PROVIDE MORE MEALS FOR THEMSELVES AND THEIR FAMILY.
5. WE SEE LARGE BIRTHDAY CAKES WITH INSCRIPTIONS, ETC. AND PARTY TYPE ITEMS BEING BOUGHT WITH FOOD STAMPS. THEN, THE CASH PORTION OF THE EBT CARD IS USED TO BUY THE NON-FOODSTAMPABLE PARTY SUPPLIES LIKE PLATES, DECORATOR NAPKING AND DRINKING PLASTIC GLASSES.

6. INSTEAD OF BUYING A HALF GALLON OR QUART OF ICE CREAM OR FROZEN YOGURT THAT DEMONSTRATES VALUE BUYING, THE WELFARE CUSTOMER WILL BUY EDY'S DIBBS ICE CREAM BITES AT \$3.89 FOR A SMALL CONTAINER.
7. THESE CUSTOMERS WILL BUY ALBACORE WHITE TUNA, WHICH IS THE MOST EXPENSIVE TUNA, INSTEAD OF THE LOWER PRICED CANNED CHUNK TUNA.
8. ONE CUSTOMER HAD TO PUT BACK 12 PACKAGES OF PREMIUM STEAKS AND BEEF BECAUSE SHE DIDN'T HAVE ENOUGH MONEY IN HER ACCOUNT. BUT, SHE PURCHASED THE SODA POP AND SNACKS THAT WERE IN THE SHOPPING CART.
9. ONCE A WEEK, AN ELDERLY LADY WILL COME IN AND BUY \$31.91 OF FOOD STAMPABLE ITEMS, YET HER BALANCE ON FEB. 12<sup>TH</sup> IS STILL \$1043.33 !!! HOW CAN THIS HAPPEN? IS THE WELFARE DEPT. UPDATING THE CLAIMANT'S PROFILE AND VISUALLY INSPECTING, IN AN UNANNOUNCED MANNER, THE CLAIMANT'S RESIDENCE, LIVING CONDITIONS AND STATED DEPENDANTS THROUGH ACTUAL VERIFICATION? EACH PARTICIPANT, IN THESE TAXPAYER FUNDED PROGRAMS, IS KEENLY AWARE OF THE "ROLL OVER TERMS", THAT WOULD EVENTUALLY REDUCE THE CLAIMANT'S BASE FUND BENEFIT AMOUNTS.

**OTHER QUESTIONABLE EXCESSES/ABUSES:**

**A. CELL PHONES:**

IT SEEMS THAT THE ENTIRE WELFARE FAMILY MEMBER HAS THEIR OWN PERSONAL CELL PHONE. WHY?????

**B. THEY HAVE LOTS OF JEWELRY, NICE CLOTHES AND DESIGNER HAND BAGS. DRIVE NEWER CARS THAT THOSE WHO HOLD DOWN SOME TYPE OF REGULAR WORK.**

**C. IT WOULD SEEM THAT IF THE CLAIMANT/PARTICIPANT**

DOES NOT HAVE "GAINFUL EMPLOYMENT" THEN  
"CONVENIENCE FOODS", I.E. "MICROWAVEABLE FOODS"  
MIGHT NOT BE NEED TO BE FOOD STAMPABLE, BECAUSE  
THE CLAIMANT HAS LOTS OF TIME AVAILABLE, TO PREPARE  
MEALS, BECAUSE THEY DO NOT WORK.

SHOULD THE DISCUSSIONS CONTINUE FURTHER, WE HAVE SOME  
SUGGESTIONS FOR STRICTER CONTROL OF WHAT ITEMS SHOULD  
QUALIFY AND NOT QUALIFY FOR THESE TAXPAYER FUNDED  
PROGRAMS. AGAIN, WE WOULD REQUEST THE WIC AGENCY BE  
GIVEN THE AUTHORITY TO DETERMINE WHICH ITEMS ARE FOOD  
STAMP ELIGIBLE. WE WOULD BE HAPPY TO WORK WITH  
APPRORIATE GOVERNMENTAL STAFF MEMBERS TO CORRECT THE  
ABUSES WITHIN THE WELFARE AND FOOD STAMP PROGRAMS.

IF ONE WOULD CONSIDER THESE GUIDELINES AND THOSE OF PENNSYLVANIA'S WIC AGENCY; THEN A FOUNDATION CAN BE DEVELOPED FOR WELFARE AND FOOD STAMP REFORM.

### PERMITTABLE ITEMS

- 1) Meat Products---Ground meat, chicken, lunchmeat
- 2) Dairy Products---milk, cheese, etc.
- 3) Vegetables-- Frozen or can
- 4) Can Goods- soups, manwich, can fruit, etc.
- 5) Bread
- 6) Fruit(if in season)
- 7) Some forms of pre-made foods.
- 8) Cereals---preferably generic/discounted brands
- 9) Boxed Items---Macaroni & Cheese, Hamburger Helper, etc
- 10) Ramon Noodles, Cup of Noodles, etc.
- 11) Fruit Juices---Apple, Orange, Cranberry, etc.

### NON PERMITTABLE ITEMS

- 1) No Steaks, Spare Ribs, etc
- 2) Soda/Soft Drinks/Sports Drinks
- 3) Any type of candy---Chocolate bars, hard candy, minty candy, gummy; etc.
- 4) Pretzels, Potato Chips, Pop Corn, Tortilla Chips, Nacho Chips, Lance Snack Crackers and other brands, etc.
- 5) Coffee, Tea (hot or cold), hot or cold flavored drinks, etc.
- 6) Desert items---Pies, cakes, brownies, muffins, fudge, etc.  
\*\*\*Pies, within limits, is acceptable for the Thanksgiving and Christmas Holidays\*\*\*
- 7) Pet foods or products of any kind. (We all love our pets, but that is something the client should be paying themselves.)

AS A FOOD RETAILER, WE FEEL THAT THE WIC AGENCY DOES A VERY ADMIRABLE JOB OF MONITORING AND PERMITTING APPROPRIATE FOODS FOR THEIR " WOMEN'S, INFANTS AND CHILDREN" (WIC) PROGRAM. WE FEEL THAT THEIR DIRECTORS AND STAFF ARE PARTICULARLY SENSITIVE TO FOODS THAT ARE HEALTHY AND AFFORDABLE.

ALSO, SINCE THIS IS ALREADY AN EXISTING COMONWEALTH AGENCY, WE FEEL THAT WIC'S INFLUENCE INSHAPING TRUE REFORM OF THE WELFARE AND FOOD STAMP PROGRAMS REFORMS. OBVIOUSLY, THE DECISION MAKERS ARE KNOWLEDGEABLE AND NUTRITION CONSCIOUS.

WE ARE SUGGESTING THAT PENNSYLVANIA, ONCE AGAIN, TAKE THE LEAD ON A NATIONAL LEVEL TO INFLUENCE REFORM OF THE FEDERAL FOOD STAMP PROGRAM, IN TANDEM WITH PENNSYLVANIA WELFARE REFORM.

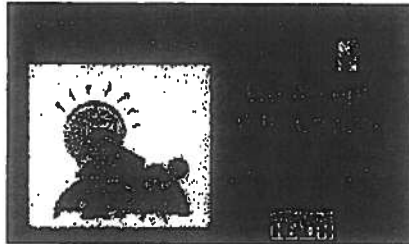

# PENNSYLVANIA WIC FOOD LIST

## **Effective:**

**October 1, 2009 thru September 30, 2010**

## **Basic Rules and Regulations**



- Use your WIC check at any WIC authorized store displaying this red WIC decal.
- Self-serve lines are not allowed.
- Checks altered in any way will not be accepted.
- WIC checks cannot be used before the **First Day to Use** or after the **Last Day to Use**.
- Only the type and quantity of food printed on the WIC check and listed in this **WIC Program Food List** can be purchased.
- No returns, rain checks, or substitutions.
- Identical exchange of store damaged product is allowed.
- Coupons, buy one get one free, extra free ounces, discount/club cards are allowed with WIC checks.



## WIC Sales Steps

- Separate WIC foods from your other groceries. Separate WIC foods by check. **Each check will be rung up separately.**
- Give the cashier your WIC ID and WIC check(s) before the sale is rung up. A WIC sale cannot be rung up without the WIC ID.
- The "Family ID Number" on the check(s) must match the "Family ID Number" on the WIC ID card.
- The cashier enters the total of each WIC sale in the "Pay Exactly" box of the check.
- Make sure the amount in the "Pay Exactly" box matches the total on the register.
- If a mistake is made entering the "Pay Exactly" amount, the cashier must draw a single line through the amount and write the correct amount above. The WIC customer must initial to verify the correction.
- Once the "Pay Exactly" box is correctly filled in, the WIC customer must sign on the "Signature of Endorser or Proxy" line and fill in the date and/or provide their WICPay key tag.

### Fruit and Vegetable Checks Only

- At the discretion of the store, checks can be combined together.
- If you go over the dollar amount of the check, you will have to pay the difference using cash, SNAP (former Food Stamps) benefits, or credit/debit card.
- If you spend less than the dollar amount you will not receive any money back.

## WICPay Sales Steps

A store displaying this purple WIC decal is a WICPay store, please also follow these steps:



- WIC customers must have their WIC ID and WICPay key tag whenever using a WIC check, without these the sale cannot be completed.
- Make sure the amount in the "Pay Exactly" box matches the total on the register before giving your WICPay key tag at the end of the transaction.
- WICPay stores could also ask you to sign the WIC check.
- The number on the back of the card is unique so key tags should not be shared.

## Fruits and Vegetables

### Fruits Allowed:

- Fresh, whole or cut without added sugars
- Frozen, without added sugars
- Canned, jarred or multi-pack, without added sugars, fats, oils or sodium (salt)

### Vegetables Allowed:

- Fresh, whole or cut without added sugars, fats or oils
- Frozen, without added sugars, fats or oils
- Canned or jarred, without added sugars, fats or oils (whole kernel corn and green peas can contain sugar)
- Sweet potatoes and yams

Organic fruits and vegetables can be purchased but tend to be more expensive. You will get more food with non-organic items.

### Not allowed:

- Party trays, fruit baskets, salad bar items
- **Ingredients other than fruit** - sugar, honey, high fructose corn syrup, heavy or light syrup, dextrose, sucrose, maple syrup, artificial sweeteners, fats, oils, or sodium (salt)
- **Ingredients other than vegetables** - sugar, honey, high fructose corn syrup, cheese sauce, noodles, rice, spices, fats or oils
- Any type of white potatoes (including Red Bliss, Purple and Yukon Gold)
- Jarred salsa, pasta sauce
- Fresh herbs and spices, edible blossoms
- Dried fruit, trail mix
- Fruit leathers, fruit snacks, fruit roll-ups
- Fruit and nut mixtures
- Fruit cocktails, cranberry sauce, pie filling
- Baked goods

### Nutrition Fact:

*Fruits and vegetables are excellent sources of vitamins, minerals, fiber and antioxidants that give you and your family many health benefits.*

## Cow's Milk

### Half Gallons or Gallons

### Types Allowed:

- Pasteurized fluid milk
- May be regular or acidophilus
- If your check says whole milk you **must** buy whole milk
- If your check says low fat milk you **must** buy 2%, 1% or skim milk
- If your check says lactose reduced, lactose free, kosher, evaporated or dry milk then you must buy the listed milk
- Dry milk must be in 1 or 2 pound packages

### Exceptions:

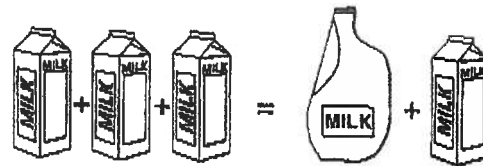
- Lactose reduced and Lactose free milk may be in quarts or larger
- You may buy a single quart of milk **only** if it is listed on your check

### Not allowed:

Flavored milk, buttermilk, goat's milk, milk with added calcium, protein or plant sterols, organic milk, UHT milk, milk in glass bottles.

These may be regular, reduced fat, low fat or fat free, low cholesterol, lactose free, low sodium, smoked or calcium fortified.

Kosher cheese must be listed on the WIC check.

Block, sliced, shredded, stick and string only. Must be marked with weight, type, and cost.

**Not allowed:**

Individually wrapped slices, imported, deli service, cheese foods, imitation cheese, cheese products or spreads, cheese with added ingredients, organic cheese, cheese packed in water.

8 ounces = 1/2 pound  
16 ounces = 1 pound

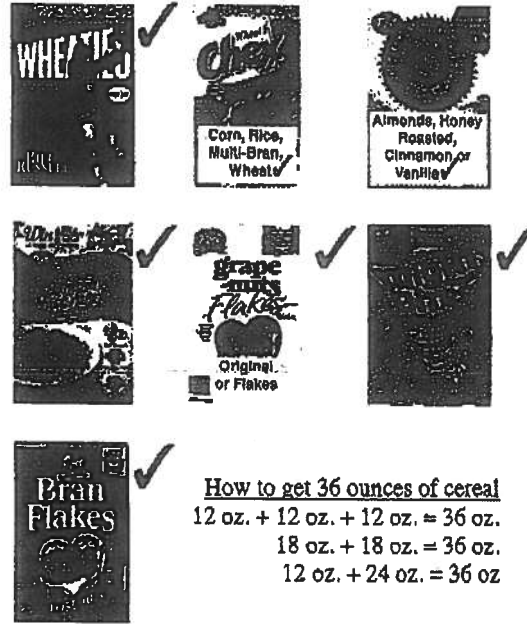

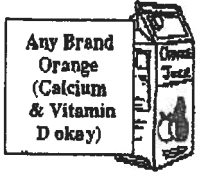

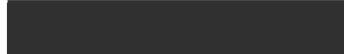
